# **CODE OF CONDUCT**



## INTRODUCTION

In preparation for your group's visit to First Wave Adventures (FWA), we would ask you to share the following information with the parents/guardians of all children within your group to help ensure children are fully aware of the importance of behavioural expectations.

We believe that the majority of children visiting FWA will act in the expected manner. This will be helped by following clear structured boundaries made up of consistent rewards to get the most out of their time at FWA.

Your group will have a dedicated Village Leader who is there to support your staff and children throughout the experience. We will endeavour to help every child enjoy what FWA has to offer, to learn new skills, and to have fun!

## EXPECTATIONS

We expect all children to follow their fundamental school rules throughout their time at FWA.

We will not accept:

- disruptive behaviour which interferes or threatens to interfere with the operation of an activity
- the use of loud or offensive language, swearing or using profane language
- using dialogue in a confrontational manner
- damaging or destroying FWA property
- the use of physical aggression towards another adult or child

## RESPECT

We require all children to respect the rights of others at FWA and respect another's differences, while taking account of each other's needs.

## REWARDS

The rewards are endless at FWA! We have a range of activities for all abilities. We positively encourage all children to take part and to succeed and celebrate their achievements. Our favourite activity is the weekly awards night to recognise and celebrate those children who have impressed the FWA staff. This could be through their positive attitudes, courage, focus, active listening, teamwork, compassion and empathy.

## CONSEQUENCES

In the unlikely event of persistent/repeated poor behaviour that risks the safety or enjoyment of others, we will be forced to ask that the child's parents collect their child.

## COASTAL AREAS

There are many dangers on the coast and many incidents affecting children have occurred by the sea. A high level of vigilance and close supervision is required near any stretch of water and particularly in tidal areas.

Remember that the sea is often very inviting and clear rules must be established. Misbehaviour could cause accidental immersion. Sudden immersion in cold, or even relatively warm, water can cause shock which could be very dangerous.
